# **PRODUCT WARRANTY**

Blackmer, Part of Pump Solutions Group/A Dover Company warrants its Models TXD2, TXD2.5, TXD3, TXD1220, TXD1225 and TXD1230 for refined petroleum products (gasoline, diesel fuel, home heating oil, jet fuel, kerosene, etc.) to be free from defects in materials and workmanship under normal use and service for which its products were designed. This warranty is for a period of 5 years (60 months) after installation or 5.5 years (66 months) after shipment from the factory, whichever comes first. If its products should fail through defect in workmanship or material within the warranty period, Blackmer must be notified in writing within the warranty period of such defects and shall have the option of requiring return of parts or product to its factory for verification of any claim. For applications other than the refined petroleum products listed above, Blackmer's standard warranty period of 12 months after installation or 18 months after shipment from the factory, whichever comes first, applies.

The warranty is in lieu of any other liability for defects. BLACKMER MAKES NO WARRANTY OF MERCHANTABILITY AND NO WARRANTY THAT ITS PRODUCTS SHALL BE APPROPRIATE FOR ANY PARTICULAR PURPOSE, nor are there any other warranties, expressed or implied, by operation of law or otherwise. This warranty does not cover any expense (labor, lost production, travel expenses, etc), incurred in repairs or alteration made outside the Blackmer factory without prior authorization, nor does it cover in any way the performance of equipment which has been revised or altered by others. The customer is wholly responsible for establishing the suitability of the product for his particular application and for operating conditions, which do not exceed published product limitations. Blackmer shall not be liable for damages or delay resulting from or related to defective products, nor for consequential, special or contingent damages for breach of warranty.

Product returns must be processed by an authorized Blackmer representative. The guide for Product Return For Warranty Inspection as defined in BLACKMER's GENERAL SALES POLICY (page 001-001 or 001-001a) must be adhered to.

# TRUCK PUMP - TWO YEAR PERFORMANCE ASSURANCE

Should any Blackmer Model TXD2, TXD2.5, TXD3, TXD1220, TXD1225 and TXD1230 pump fail in the transfer of refined petroleum products (gasoline, diesel fuel, home heating oil, jet fuel, kerosene, etc.) within 2 years(24 months) after installation or 2.5 years (30 months) after shipment from the factory, regardless of cause (except for intentional or gross misuse), free replacement components will be provided to return the pump to as new performance.

This offer is limited to one claim per installation.

## PERFORMANCE ASSURANCE LIMITATION OF LIABILITY

Blackmer's obligation under the TWO Year Performance Assurance is expressly limited to replacing **failed** parts. In no event will Blackmer be liable for lost production, damage or loss to persons or property, labor, travel expense, and/or consequential damages. The limit of liability is up to the cost of a new, as like pump.

Blackmer reserves the right to have the damaged parts returned to the factory for inspection. This is to verify that the problem is tracked for Quality Assurance. The parts or pump must be returned in accordance with Product Return For Warranty Inspection as defined in BLACKMER's GENERAL SALES POLICY (page 001-001 or 001-001a).

## **HYDRAULIC ADAPTER:**

For pumps driven by hydraulic systems, the 5 year warranty and 2 year performance assurance guarantee requires use of genuine Blackmer made hydraulic motor adapters. Use of any 3rd party hydraulic motor adapter voids the 5 year warranty and 2 year performance assurance guarantee.
